

What is Behavioral Health Court?

Behavioral Health Courts are specialized treatment courts for eligible justice involved individuals living with mental illness that substitute a problem-solving model for traditional justice system case processing. Through partnership with community providers and resources, Judges and treatment court staff are able to connect participants with mental health supports to help manage symptoms and regain their mental wellness. Behavioral health courts require participants to attend court regularly for frequent appearances in front of the Judge, status updates, and program monitoring. Additionally, SCBHC requires participants to maintain medication compliance and attend self-help meetings.

How to Apply

The screening process starts with your attorney applying through the District Attorney's Office.

Less Government Spending

Alternative to Incarceration in county jail means that for every participant in the program, approx. \$42/day to house an inmate is not being spent.
